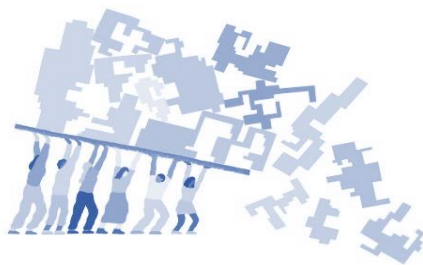




San Marcos ISD 2022 - Plan A
