
The District may apply to the Commissioner of Education for an additional amount of up to ten percent of its regular transportation allotment to be used for the transportation of students living within two miles of the school they attend who would be subject to hazardous traffic conditions if they walked to school. The Board shall provide to the Commissioner the definition of hazardous conditions applicable to the District and shall identify the specific hazardous areas for which the allocation is requested. A hazardous condition exists where no walkway is provided and students must walk along or cross a freeway or expressway, an underpass, an overpass or a bridge, an uncontrolled major traffic artery, an industrial or commercial area, or another comparable condition. Executive Summary Student Transportation Hazardous Route Descriptions for SY 2021-2022

There are ten primary/secondary campuses; Bowie Elementary School, Crockett Elementary School, De Zavala Elementary School, Hernandez Elementary School, Mendez Elementary School, Rodriguez Elementary School, Doris Miller Middle School, Owen Goodnight Middle School, San Marcos High School and Lamar Learning Center that have a small area within their two-mile zone that is not hazardous. Consequently, TEA will not reimburse San Marcos CISD for general education student transportation services in these areas.


Bowie Elementary School:

No streets within the Cottonwood Creek subdivision meet the hazardous route criteria. All other areas outside of the Cottonwood Creek subdivision are hazardous due to no sidewalks, uncontrolled traffic artery, or another comparable condition.



Bonham Pre-Kindergarten:

All areas are hazardous due to no sidewalks, uncontrolled traffic artery, or another comparable condition.




Crockett Elementary School:

All areas west of Franklin Dr., south of N Bishop St., east of Hazelton St., and north of Perkins St. are hazardous due to no sidewalks, uncontrolled traffic artery, or another comparable condition. All other areas do not meet the criteria of a hazardous condition within the two-mile Zone of Crockett elementary zone.



Lorenzo DeZavala Elementary School:

No streets within the Hills of Hays subdivision meet the hazardous route criteria. All areas outside of the Hills of Hays neighborhood are hazardous due to no sidewalks, uncontrolled traffic artery, or another comparable condition.



Maria Hernandez Elementary School:

The follow streets do not qualify as hazardous: Hunters Hill Dr., Sageleaf Willow, White Willow Dr., Autumn Willow Dr., Sky Springs Pass, Foxtail Run, Cavallo Springs Cove, Mary Max Cir., Mary Max Cove, Braeden Brooke Dr., Deer Stand Loop, and Missum Point. All other areas are hazardous due to no sidewalks, uncontrolled traffic artery, or another comparable condition.



Irene Mendez Elementary School:

The follow streets do not qualify as hazardous: Del Sol Dr., Parkdale St., Lockwood St. Candlelight Ln., Patricia Dr., Magnolia Dr., Oakdale Dr., Ebony St., Woodcrest St., and Parker Dr. All other areas are hazardous due to no sidewalks, uncontrolled traffic artery, or another comparable condition.




Rodriguez Elementary School:


Travis Elementary School:


Doris Miller Middle School:
